



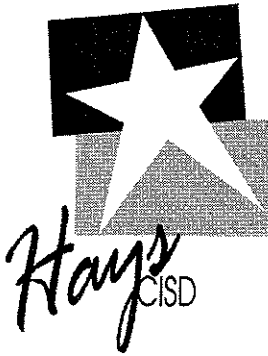
I have visited their offices and have seen their capability of taking a portable from design through construction.

Hinojosa, have been with the Austin Independent School District since 1985 and have been in charge of relocating and constructing temporary portable classroom buildings for the district since 1986. During those years Industrial Laminates Corporation (ILCOR) has constructed numerous portables for AISD. I have heard many people refer to our portables as "ILCOR" portables although they were not all built by ILCOR. I do believe that our portables were originally designed by ILCOR in the mid 1960's. We have made changes and improvements to the original design to keep up with local codes, ADA and technology requirements.

My first dealings with ILCOR were with Mr. Bob Kelly in 1986. In 1994 I had the pleasure of meeting his daughter, Mrs. Cathy Wimbish and his son Rob Kelly, as they became my contacts at ILCOR.


